  - ADFA Susan Garner spoke about the HMIS payment.

- V. Balance of State Update
  - <u>Collaborate Applicant</u> Sue Legal gave the update for Loren Morphen. The official PIT Count planning will begin in August. All LHC's will receive further information this month. Spring Hunter has stepped down from the Toad Suck LHC and was the vice chair. We're in need of all LHC coordinator to fill that role. Loren will be covering that role in the meantime. I also received an email from E Snap that the FY 25 NOFO will be coming out.
  - Homeless Program Director Sue Legal gave the update for Mark Sniff. He has
    said that the Steering Committee is working on finalizing visibility of HMIS across
    the state. This change will allow us to view prior enrollments for clients who are
    served in different areas of the state. We're working to finalize a statewide used
    release of information document adding consistency to intake for HUD funding
    program. Please reach out if you have any training needs or questions regarding

  - Sue Legal In the ESG meeting they informed everyone that ESG recipients will receive negative points next year during next year's application if they are not using HMIS the way they're supposed to be doing throughout the year.
  - <u>Coordinated Entry</u> Autumn Johnson Myself and the Coordinated Entry committee are still working on policies and procedures. Hopefully I will be able to get a rough draft finished and into the Coordinated Entry Committee by the next CEC meeting. I am still trying to meet and discuss in LHC meeting with them about access points. If anyone has questions about access points please call or email me.

- Autumn Johnson has asked the board to vote on the AR Balance of State
   Coordinated Entry Assessment Triage Tool. It was sent out for the June Board
   meeting. It was voted on, first by Miracle and 2<sup>nd</sup> by Josephine. It was passed by
   the Board.
- William Tollett wanted to go over the payment of HMIS and who is providing the funding for the \$1,000.00. Susan Garner from ADFA commented on this issue. We are throwing more money into the HMIS category one for you to build up your staff capacity when it comes to HMIS, and who is going to be doing it and who is going to be monitoring that for your agency. We have paid it this year since we took over for DHS and they paid the contract fees licensing. Going forward we will be working with HUD and with HMIS lead CoC leads to organize the structure of paying the contract.

We did not go with the Rank and Review Committee, even though it could have fallen underneath them. There would have been a conflict in the members of the committee being recipients and of the ESG grant. This is the reason that we look beyond that and spread the scope out.
