- IV. Second item of Business: Governance Charter
  - We needed to do some updating of our governance charter to put it in compliance. And we had a period of time where individuals could send in questions. So, I want to go through the six questions that were submitted and to give us an opportunity to respond to those.
  - 1. Section 5A & 5C. This is regarding voting members with homeless experience. 5A, it stated they're within the past five years then 5C, it stated seven years. The question was should these be the same? This was an oversight and has been fixed to both being 5 years. This also allows it to math up with the ESG requirements to have a homeless representative on your local board with experience within the past five years.

2. Do we have any members on the Balance of State body that has prior homeless experience? The answer this is yes, we do. We have individuals that will come and serve on various committees and have chaired on the Rank and Review Committee.
3. Are there any current CoC funded projects if so, what agency and for what system do those projects exist? This has been discussed and we will be adding this to our website. You will be able to look up those CLC recipients who were funded and their projects and what those projects entail. Loren is working on getting that information up on the website.
4. A question was asked if this document is separate from your local LHC. The government's charter that was reviewed for the Balanced Estate is at large, and it serves the Balanced Estate, but it does not necessarily allow itself with your local LHC.
5. Section 6A, Board Terms – We removed from the bylaws regarding a statement on unlimited consecutive terms. We felt that there needs to be term limits. WE have changed this to two-year term limits simply to have fresh ideas and new agencies getting involved.
